

Nexford International Transfer Scholarship

Nexford International Transfer Eligibility Requirements:

1. The recipient must be a former or current student or graduate of Nexford University transferring into a Strayer University degree program and registering for the April 1, 2024, start, summer 2024 quarter, fall 2024 quarter, or winter 2025 quarter in a Strayer University undergraduate or graduate degree program.
 - a. Certificate programs, the Jack Welch Management Institute (JWMI) program, Devmountain and Hackbright programs, Degrees@Work programs, and VerizonOnsite programs are ineligible for this scholarship.
 - b. You are not a U.S. citizen. If you become a U.S. Citizen, as defined by the United States law and regulations, while enrolled at Strayer, you will forfeit the scholarship.
 - c. You are required to notify Strayer University if your citizenship status changes.
2. The Nexford International Transfer Scholarship will pay 50% of the student's remaining tuition for eligible courses taken at Strayer University.
3. The recipient must provide proof of current or previous enrollment at Nexford University in form of an unofficial transcript, official transcript, or awarded degree; or through the use of a confirmed student/alumni e-mail.
4. The recipient must meet Strayer University admission requirements.
5. The recipient is not a citizen of a country that is on the U.S. Department of Treasury Office of Foreign Assets Control sanction list. (Information about this list can be found here: <https://home.treasury.gov/policy-issues/office-of-foreign-assets-control-sanctions-programs-and-information>.)
6. The recipient understands and agrees that this scholarship applies to tuition only. All other fees, including technology fee, final academic requirement fee, books, course materials, and non-obligatory fees must be paid by a separate method of payment.
7. The recipient understands and agrees that once eligibility is confirmed, the scholarship will be applied to your account during each eligible quarter of enrollment.
8. The recipient understands and agrees that this scholarship cannot be combined with other scholarships offered by Strayer or tuition assistance aligned pricing (TAAP) discounts (also known as employer discounts).
9. The recipient understands and agrees that the scholarship may not be combined with corporate alliance/national account discounts.
10. Bachelor's students only:
 - a. The recipient understands and agrees that the scholarship may not be combined with the Graduation Fund if you are enrolled in a bachelor's program.
 - b. The recipient understands and agrees that the scholarship may be combined with the laptop program if you are enrolled in a bachelor's program and living in the United States.

11. The recipient understands and agrees that Strayer does not represent or guarantee that its degree programs are accredited, recognized, or likely to be accredited, recognized, or granted equivalency or validation by any non-U.S. country, non-U.S. educational authority, or any other educational institution. Recognition, equivalency, and validation of Strayer degrees are determined on a country-by-country basis by each country's educational authorities, and by each individual institution at which the recipient seeks equivalency. Strayer international students are advised to independently review the degree recognition, equivalency, and validation procedures with the relevant organizations in their country and any other institution the student may consider attending to determine if Strayer credits/degrees would be recognized.

12. The recipient understands and agrees that if the recipient is moving to the United States, then they must meet all international admission requirements as outlined in the Strayer catalog and must comply with all applicable laws and regulations as part of their resident status in the United States. The recipient also agrees to review and consult, if necessary, the U.S. State Department's current rules and regulations:

13. The recipient represents that neither they, an immediate family member or household member of theirs are currently employed by the University, the University's parent company, or any other subsidiary of the parent company (Strategic Education, Inc.).

14. The recipient understands and agrees that they are subject to all academic policies and procedures applicable to Strayer University students, as provided for in the catalog.

15. The recipient agrees to maintain good academic standing (GPA 2.0 or greater for undergraduate programs, 2.5 or greater for graduate programs) during the entire time that they are receiving the scholarship. Any quarter following the quarter when they fail to maintain good academic standing, the scholarship will be forfeited until they return to good academic standing.

16. The recipient understands and agrees that if they do not register for or drop all courses during a quarter where the scholarship is disbursed, they forfeit the scholarship for that quarter.

17. The recipient understands that if they choose to change to an ineligible program, discontinue or withdraw (either voluntarily or involuntarily), they will become ineligible for this scholarship.

18. The recipient understands that if they take two or more consecutive quarters off, they will forfeit the scholarship benefits and will not be entitled to the scholarship in the future.

19. The recipient agrees that if they are conferred a degree and start their next degree within 3 quarters of graduation, their scholarship will carry over to their next degree if that program is also eligible for this scholarship.

20. The recipient understands and agrees that this scholarship has no cash value, and under no circumstance will they be eligible for a refund, cash payment or any other compensation for the value of unused scholarship funds and/or disbursements.

21. The recipient understands and agrees that if their tuition is billed to an employer or sponsor, the scholarship is applied first to tuition charges and then the sponsor is billed the remaining net tuition amount.

22. Recipients who switch to an ineligible program such as a different bachelor degree, associate degree, Devmountain, Hackbright, Degrees@Work or VerizonOnsite, discontinue enrollment (i.e., two or more consecutive quarters off) or otherwise withdraw from Strayer will forfeit all rights to the scholarship and have all future scholarship disbursements canceled. The scholarship automatically terminates upon graduation from Strayer.

23. Recipients who do not remain enrolled through the first two weeks of the quarter or billing session will forfeit the award for the missed quarter or billing session. The missed quarter will count as an unenrolled quarter for purposes for continued scholarship eligibility.
24. Recipients of the scholarship must read and agree to terms presented in the award agreement prior to the start of the first application of the scholarship funds.
25. Students may not use the scholarship funds to pay for a repeat course, including repeats due to dropped courses that resulted in a final grade of WF or WP.
26. The recipient understands and agrees that in all cases, the scholarship is offered at Strayer University's discretion.
